- Pursuant to the Law on the State Bank of Viet Nam dated 16 June 2010, as amended and supplemented;
- Pursuant to the Law on Credit Institutions dated 18 January 2024, as amended and supplemented;
- Pursuant to Resolution No. 190/2025/QH15 dated 19 February 2025 of the National Assembly on the handling of certain issues relating to the reorganization of the state administrative apparatus;
- Pursuant to Decree No. 26/2025/ND-CP dated 24 February 2025 of the Government prescribing the functions, tasks, powers and organizational structure of the State Bank of Viet Nam;
- Pursuant to Decision No. 276/QĐ-NHNN dated 24 February 2025 of the Governor of the State Bank of Viet Nam prescribing the functions, tasks, powers and organizational structure of the the Credit institution management and Supervision department;
- Pursuant to Circular No. 35/2024/TT-NHNN dated 30 June 2024 of the Governor of the State Bank of Viet Nam providing for the licensing, amendment and supplementation of licenses and the organization and operation of credit institutions and foreign bank branches;
- Pursuant to Circular No. 21/2012/TT-NHNN dated 18 June 2012 of the Governor of the State Bank of Viet Nam providing for lending, borrowing, purchase and sale with recourse of valuable papers between credit institutions and foreign bank branches, as amended and supplemented;

Considering the request of BIDV – SuMi TRUST Leasing Company Limited in Documents No. 1171/2025/CV-BSL dated 11 August 2025, No. 1449/2025/CV-BSL dated 06 October 2025, No. 1831/2025/CV-BSL dated 19 December 2025, and No. 70/2026/CV-BSL dated 20 January 2026, together with the enclosed dossiers and documents;

At the proposal of the Head of the Division in charge of supervision and regulation of non-bank credit institutions.

HEREBY DECIDES:

Article 1. To supplement Clause 7, Article 4 of License No. 33/GP-NHNN dated 12 April 2017 issued by the Governor of the State Bank of Viet Nam to BSL, as follows:

“7. Other activities:

k) Lending and depositing money with credit institutions and foreign bank branches in accordance with the regulations of the Governor of the State Bank of Viet Nam.”

Article 2. This Decision shall take effect from the date of signing and shall constitute an integral part of License No. 33/GP-NHNN dated 12 April 2017 issued by the Governor of the State Bank of Viet Nam to BSL.

Article 3. BSL shall be responsible for fully complying with the provisions stipulated in Article 4 of the Law on Credit Institutions 2024, as amended and supplemented, and other relevant laws with respect to the supplemented business activity specified in Article 1 of this Decision.

Article 4. The Chairman and members of Board of Member, the Head and members of the Supervisory Board, and the Chief Executive Officer of BSL shall be responsible for the implementation of this Decision.
